- Not "anti-hunting" measures
- Proclamations
  - Opposing
  - Asking MI policy makers to ban them (Kalamazoo)
  - Forwarding resolution to County representatives in Lansing requesting they advocate for a state-wide ban (Washtenaw)

#### Fur Sales Ban

- Ann Arbor City Council,
   August 2021
- Passed Unanimously
- Ban is 1<sup>st</sup> in Midwest city;
   1<sup>st</sup> in fur-producing state
- Passed Unanimously
- Sponsor: "Furriers need to go the way of the buggywhip makers"
- Policy statement: animal suffering, environmental impact, public health that go against city's values

#### SAFE DEER MANAGEMENT IN OAKLAND COUNT



The Farmington Hills City Council is creating a coalition of communities in Oakland County to develop a plan for deer management as an attempt to reduce deer-vehicle crashes and protect landscaping. We want this coalition to know that we do not support lethal measures, as there are safe and effective

NONLETHAL strategies to promote respectful coexistence between people and deer.

Reduce Deer-Vehicle Collisions By... Cutting back brush where deer travel,, using temporary flashing deer crossing warning signs, reducing speed limits in certain locations, building fencing along roads, and creating a county-wide safe driving education program. There is also ongoing successful research results on fertility control, such as PZP immunocontraception (which we need to persuade the MDNR to permit).

<u>Protect Landscaping By...</u> Learning from experts and resources that provide information on how to deer-proof one's landscaping. The city can link to these resources on their website and invite an expert to offer a workshop for the residents of Oakland County. Additionally, we need to inform citizens of the deer feeding ban and enforce it. Some of the resources include:

#### Deer Cull

- City of Farmington Hills: summer 2021 and ongoing
- Next date: September 21,2021
- Note: effort to create coalition of Oakland County Communities to address deer-car collision problem
- Lethal management often preferred method

#### WHY KILLING DEER IN THE CITY IS A BAD IDEA

**INEFFECTIVE**: Deer culling has been proven an ineffective method of deer herd reduction. Remaining deer have less competition and more food. They adapt fast and become stronger, resulting in increased reproduction rates (see 'Compensatory Rebound Effect'). In addition, once the population drops temporarily, other deer from surrounding neighborhoods will immigrate into less densely populated green areas to forage for food. A 1-year cull will become a never-ending annual and costly slaughter without a significant reduction in deer-vehicle accidents or damage to landscaping.

**UNSAFE**: Culling in densely populated areas IS a safety hazard for residents, their families, their animal companions and other wildlife. Stray bullets can travel miles. Accidents involving the police force in a culling operation have happened in nearby communities such as Flint, MI. Wounded deer, from bullets or arrows, jumping into traffic are an additional hazard.

**UNNECESSARY**: Significant reduction of deer-vehicle crashes in high accident areas can be achieved with a combination of non-lethal methods such as improved signage, speed limit reduction, proper landscaping of road sides, lighting, etc., as well as with responsible motorist behavior.

**COSTLY**: Communities where culling has been implemented have become a direct contributor to deer overpopulation and have spent year after year and hundreds of thousands of dollars in taxpayers money on a vicious circle of killing that has failed to significantly reduce deer-vehicle crashes.

#### THE SOLUTION:

Let the city know that we do not support a deer cull in Farmington Hills or Oakland County. We want the coalition to use nonlethal deer management strategies because they are safe, cost-effective, and successful long-term measures.

- Genoa Township, MI (ongoing)
- DNR considers them "invasive", prohibits them from being rehabilitated and has system whereby local government or residents can petition to have DNR "remove" them
- July 2021: Township responds to complaints by lake property owners and passes resolution authorizing DNR "removal" anywhere in township
- August 2021 and continuing: local, national activist stage protest:
  - DNR action not backed by science
  - Swans being demonized and are simply responding to jet skiers, noise that threaten them
